CALL FOR PAPERS

About fifty years ago legal education meant to produce graduates who would mostly join the bar; few to bench, and fewer into teaching of the subject. Post liberalization year 1991, legal education changed from traditional scope to multi-dimensional one to meet, not only the requirements of the bar and the new needs of trade, commerce and industry but also the requirements of globalization. New law subjects, with international and multi-disciplinary approach, emerged in legal education which include International Trade, Environment, Cyber information, Education, Health, Comparative Law, Conflict of Laws, or International Human Rights Law, Gender Justice, Space Law, Bio-medical law, Bio-ethics & International Advocacy etcetera. Apart from bar and bench domain, there is increasing demand of law graduates in other fields like academics, corporate sector, taxation firms, regulatory bodies, and business groups etc. There is also enormous need for non-practicing law graduates in trade and commerce. Therefore, the Legal education needs to be re-shaped, and remodeled to orient the tastes and inclinations of law graduates accordingly for those—

- a. Who practice law;
- b. Who want to become researchers and teachers;
- c. Who deal exclusively with academic subjects of substantive law;
- d. Who deal with public legal education or Para-legal education;
- e. Who prepare law graduates to deal with legal, and ethical issues in active sectors of domestic, family international business and industry as well;
- f. Who conduct research in furthering the cause of policy making;
- g. Finally, the type who discharge their role as regulatory bodies to supervise the legal, as well as cross disciplinary professionalism in the country.

In this backdrop, Kashmir Law College, Nowshera, Srinagar, is going to organize Two Day National Seminar.

- Original contributions based on applications/research/ surveys/ practices related to the theme and sub-themes mentioned above are invited for the seminar. Only those participants shall be provided paper presentation certificate who present their papers. Further, for presentation certificates all joint authors need to register and submit fee as well;
- Based on seminar committee's recommendations, only accepted papers will be allowed to be presented during the Seminar. All abstracts/ papers/ should be submitted to academicevents.klc@gmail.com by or before the scheduled date;
- Maximum number of papers is restricted to only two either by individual or by collaboration.
- Based on the seminar committee's decision, acceptance of papers for presentation will be intimated to the author along with schedule.
- Selected papers shall be considered for publication in **Kashmir Journal of Legal Studies** [UGC CARE listed Journal], [www.kashmirjournaloflegalstudies.edu.in] on contribution of usual Article Processing Charges, and the fulfillment of other publication formalities;
- A Certificate of Participation shall be given to each registered participant who presents the paper;
- Light refreshment shall be served during the program to all the participants of seminar.

MANUSCRIPTS REQUIREMENTS

Length: Not more than eight pages for a paper. However, the authors are advised to maintain brevity, precision and coherence in their papers.

Font & Size: Times New Roman. Font Size: Heading-14 (Bold), Sub-heading -12(Bold), and rest of the text - 12.

Spacing- 1.5, Format: dox/doc

Title: The title should be concise. **Citation Style:** Indian Law Institute format.

Abstract: Not beyond 150 words.
